Declaration of liability and general confirmation

Dear participants of the TrailTrophy Breitenbrunn 2020,

please sign this disclaimer and further agreements or declarations and return them to the race office. The start can only take place after the declaration has been submitted. Thanks a lot!

1. Description of the risks:

The participant knows and is fully aware of the dangers associated with the practice of extreme sports, especially mountain biking, such as the dangers caused by fatigue during the competition. The participant acknowledges that there is a risk associated with the pursuit of special sporting achievements. The participant accepts for himself/herself that life and physical safety may be endangered by the practice of such competitive sports. This includes dangers for everyone in the competition area, especially from environmental conditions, technical equipment, atmospheric influences, dangers from public roads, as well as natural and artificial obstacles. The participant accepts that in case of driving on public roads, the rules of the road traffic regulations apply. The participant assures that the data of his entry is correct and that he has read and accepts the announcement, the exclusion of liability, the conditions of participation and the regulations. As a participant, I declare that I have trained for the TrailTrophy Breitenbrunn 2020, that I have fully met the requirements and that I am physically healthy. In the event of cancellation of the event due to force majeure or cancellation for serious safety reasons by the organiser, there is no claim to a refund of the entry fee.

2. Disclaimer of liability

My participation in the TrailTrophy 2020 in Breitenbrunn is at my own risk. With my registration I assure that I am in possession of a valid accident and liability insurance at the time of the event. I waive all legal claims - including third parties - to the event with my signature. I declare that my training and state of health is in accordance with the requirements of the competition. I hereby expressly indemnify the organiser Bike Projects GmbH from all claims which arise in connection with the event TrailTrophy 2020, in particular due to an accident, whether caused by my own fault or by a third party or for any other reason, against Bike Projects GmbH, its legal representatives, vicarious agents or assistants. This waiver of liability shall apply to claims on any legal grounds whatsoever, in particular to claims for damages from both contractual and non-contractual liability.

The organiser and promoter Bike Projects GmbH does not assume any liability for loss or damage of valuable objects. Likewise, the organiser Bike Projects GmbH is not liable for damage that occurs during the transport of bicycles in motor vehicles, on car trailers or during the use of ascending aids (e.g. lifts).

3. Declaration of consent Dissemination of images/rights of use

As a participant I give my consent that photos and film recordings (portraits) may be taken of me in the course of my participation in the race.
